***** Rationale:

Between 1981 and 2001, a wide range of university linkages between Chinese and Canadian universities were supported by the Canadian International Development agencies under three major project envelopes, the Canada-China Management Education Program [CCMEP] (Part 1, 1983-89, Part 2, 1990-96), the Canada-China University Linkage Program [CCULP] (1989-1995) and the Special University Linkage Consolidation Program [SULCP] (1996-2001). While CCMEP had a total budget of about \$50 million, CCULP and SULCP attracted \$29 million in funding from CIDA. A large number of Canadian and Chinese universities were involved in these projects, and short term outcomes were documented in various reports. However, there has been little reflection on the long-term outcomes of these projects or on the later work and influence of participants on both sides. No succinct analysis has been made of the contribution of t

social and economic transformation over the last two decades of the 20th century, or of the enduring impact they had on the international work of Canadian universities. The areas of knowledge covered included management, health, environment, agriculture, engineering, education and culture. There was a wide geographical spread of institutions in both counties, with CCMEP being led by eight or nine top ranking institutions on both sides, while CCULP and SULCP involved a wider range of institutions of different types and levels.

The purpose of this conference is to bring together leading scholars and administrators on both sides, who were personally involved in the projects and can look back on the impact they had at the time on the participating institutions, the fields of knowledge and the process of social change underway at the regional and/or national level. We have invited senior Canadian and Chinese scholars to present keynote addresses. In addition to their historical analyses, we invited them to reflect on contemporary synergies between Canada and China, and areas where new kinds of university linkages between institutions in the two countries could invigorate scholarship on both sides and contribute to deepened understanding and positive social change. We believe the legacy of the past should be preserved and thus we are planning an edited book, which will include some of the keynote papers.

While the keynote addresses will occupy more than half of the conference time, we have also opened up the conference widely to interested participants who are now engaged in collaborative activities between Canadian and Chinese universities, and are eager to gain familiarity with this legacy from the past and brainstorm over current opportunities and future challenges in various fields of





XIE Weihe is the vice president of Tsinghua University, professor and Ph.D. supervisor. He is also the dean of Institute of Education Tsinghua University, and a famous scholar in sociology of education. He was one of the 10th CPPCC national committee and served as a deputy to the 11th National People's Congress. From1978-1982, he studied in the Department of Philosophy of Xiamen University and got a B.A. degree. He got the master's degree from Nanjing University in 1985 and was awarded the PhD degree in Graduate School of Chinese Academy of Social Sciences in 1988. He served as vice president of Beijing Normal University from January 1997 and secretary of the Party committee of Capital Normal University from April 2004. He has been served as Vice President of Tsinghua University and dean of the Institute of Education since July 2004.

He has presided over and completed more than 10 research projects hold by the country, the Ministry of Education, Beijing, and the World Bank. Professor Xie is the author of 9 books. In addition, he has published more than 80 articles in many journals, including *Educational Research*, *Journal of Higher Education* and translated many academic works.

Presentation: Canada and China, whither our future cooperation?

Abstract

In this paper I try to explore and describe the various joint activities in the past where the material results were accompanied by the beginnings of true intimacy between our countries. In fact, as we examine these questions, we must admit that China itself has outpaced our expectations. Instead of the opaque phenomenon that old Chi

and other media with a diversity and quantity of data that none of us ever dreamed of a few years ago. The gates thus opened into Chinese society, and even government, do not quite yet take us into the far reaches of political decision-making, but they do make our own formulation of questions much easier. So, as our two countries still remain a huge distance apart in their—respective economic progress, Canada an industrialized economy with a modest rate of growth scarcely sufficient to raise the average income of its citizenry, while China, in the full throws of rapid industrialization managing to increase its capacities and riches at a remarkable rate.

The type of cooperation that is now called for is now quite clearly no longer in the realm of economic

predecessor in the race to modernize their structures or production facilities has demonstrated spectacularly that the most recent newcomer ion this sort of race management each time to do it more rapidly. Moreover, they do it with a higher degree of innovation.

On the other hand, the increasing challenges the world faces today are of a complexity requiring all major international actors to join forces in the development of new technologies This is where the complementarity of our two economies will for the first time come into its own by striving jointly to create a new dynamics of international cooperation to help the world overcome he environmental threats to our planet.

The work that has been done so far by Canadian universities collaborating with their Chinese counterparts, be it in the fields of Canadian or Chinese studies, the modernization of social and political structures, the advance of hydroelectric energy production, the reduction of CO2 emissions, the handling and transport of grains, the treatment and avoidance of externally induced cancers, as well as the many other joint educational projects of the past should be grist for the mills of our future joint endeavours.

Presentation: Universities as Educators and Innovators in the Development of the Canada-China Relationship

Abstract

The context of collaborations in higher education between Canada and China has shifted dramatically in the past two decades. Based principally on the experience of the University of British Columbia in relations with a range of Chinese partners in almost one hundred collaborations, the presentation will look at five dimensions of this shift: purpose and drivers of collaboration, range of subject areas, principal proponents and players, business models and funding, and role of governmental institutions.

The presentation will draw on the findings of a major survey of UBC's China activities and an analysis of comparative developments at 15 comparator institutions in Canada, the United States, Australia and Hong Kong. It will conclude with some ideas of what "Partnerships 2.0" might look like, including prospects for

rotating faculty appointments, large-scale experiential learning collaborations, joint degrees, and e-curriculum.

Dr. Dilantha Fernando is an internationally recognized plant scientist, a professor at University of Manitoba who has contributed to managing diseases through environmentally-friendly methods around the world. His research has impacted the world with reduction of pesticide use, and poverty alleviation especially in China, India and Sri Lanka. He has contributed to the development of 32 canola/rapeseed cultivars that are grown in Canada. He has been recognized numerous times through awards, invitations by many countries for keynote addresses at international conferences, to numerous boards, as an Editor-in-Chief and Editor by two prestigious journals in the world. In addition, he has trained over 70 graduate, post-doctoral and visiting scientists. The training of HQP in his lab has contributed to science in a major way, with many firsts and discoveries that have been published in high impact peer reviewed journals bringing recognition to Canada.

Presentation: An Extreme Makeover of Canola/Rapeseed Genetics for Poverty Alleviation in Rural China: a Successful CIDA Funded Partnership between U of Manitoba and Huazhong Agricultural University

Abstract

Canola (Canada oil low acid) is the healthiest edible oil on the market. It has the lowest amount of saturated fatty acids, and abundant amounts of essential mono and poly unsaturated fatty acids. Although rapeseed had existed in China for many years and used for numerous industrial purposes the cultivation of oilseed rape as edible oil has been quite recent and a livelihood for many rural farmers. The CIDA funded CCULP/SULCP project brought two major breeding programs of the world to collaborate and in partnership train High Quality Personnel, to increase yield, oil quality and disease resistance in the oilseed rape/canola crop in China. The partnership enabled Chinese farmers to increase their acreage and price per ha with new and improved canola-quality oilseed rape. The partnership also allowed improving the processing and meal utilization while promoting international cooperation between China and Canada. Several young researchers from China were trained in Canada and on their return have excelled in their field of research breeding several high yielding canola cultivars, winning prestigious awards and becoming top level administrators of their respective units or the university. The Canadian academics have benefited immensely through the training of HQP from HAU and being able to work in China with HAU academics and farmers beyond the CIDA funded period and establish new funding for collaborations. My own experience on this has helped me develop a network in China where I have established numerous collaborations with agricultural universities on research on breeding for disease resistance and host-pathogen interaction studies in both canola and wheat crops.

Presentation: Sino-Canadian Legal Partnerships in Law and Education: Genesis, Groundwork and Growth

Abstract (Guy Lefebvre with Marie-Claude Rigaud and Elizabeth Steyn as co-authors)

The Faculty of Law at the Universit éde Montr éal began its relations with China in 1998 when the Canadian International Development Agency (CIDA) mandated the Faculty to collaborate with the National Judges College of China. The project was aimed at training judges about the rule of law and the study of Western legal systems. This initial collaboration paved the way to multiple exchanges and agreements with several prestigious Chinese universities, namely CUPL, East CUPL, Wuhan, Chinese Academy of Social Sciences and now Tsinghua and Shanghai Jiao Tong. Since 2002, this extensive network has allowed more than 500 Canadian law students to study in China. In addition, since 2002, approximately 30 Chinese students come to Montreal to learn more about our legal system and tradition in the context of a summer program offered by the Faculty. Since 2006, some forty students from China enroll in our Master's program "Business Law in a



Global Context", a program specially designed for foreign students. In the area of research, many members of our Faculty have undertaken various projects with their Chinese counterparts. This alone has led to the organization of various conferences and to the publication of many papers in peer reviewed journals in both China and Canada. Finally, several Chinese students either pursue doctoral studies at our Faculty or come as visiting research fellows.

Thanks to the solid relationships it has weaved with various Chinese universities, the Faculty now wishes to invite new partners, including those coming from emerging countries of the southern hemisphere. The Faculty thus faces the many challenges of moving from a bilateral model of relations with China to a paradigm of multilateral action.

Presentation: Transforming Canada-China Educational Cooperation: Legacies and Future Challenges in Management Education

Abstract

From the perspective of a Canadian CCMEP-participant, both as teacher and linkage coordinator, the paper pieces together evidence of the impact of the CIDA-funded cooperation in Management Education on a) the social and economic transformation of China, and b) the internationalization of the participating universities.

Part four will address the changes the cooperation set in motion at Canadian management schools, again

illustrated by input from former linkage alumni. This influence ranges from case studies and journal articles on Chinese management to student exchanges, China-focused degrees, Canadian careers, and even textbooks and dedicated academic journals.

Part five will draw on the past experience, look to the future, and attempt to identify possible topics for cooperation. For example, the imminent convertibility of the RMB presents opportunities for institutionalized cooperation on the regulation of international banking and finance.



Presentation: Canada-China Collaboration in Cancer Treatment and Prevention and its Broader Social Impact

Abstract

The Norman Bethune University of Medical Science established a collaborative relationship with Laval University in 1990 and its first phase of cooperation focused on support for Norman Bethune to strengthen and increase its ability to serve cancer relief in the region. A new unit was established on September 18 of 1991, which combined functions of medical treatment, teaching and research in dealing with cancer, and was called the Bethune Laval Onco

treatment to the Chinese context and had a high degree of success within a short period of time. When the project entered its second phase in 1996, its objective was to improve the training of personnel dealing with tumor cells, greatly expand the reach of the tumor registry, and greatly expand public education and awareness of cancer. The two phases of the project continued for eleven years and at the close of that period the second international conference on tumors was held in Changchun, as the project was coming to a close. There were over two hundred specialists attending the conference, including many international experts, also some government officials, and all gave a very high evaluation to the results of this collaboration.

Professor FU Tingdong: Academician of the Chinese Academy of Engineering; Professor of Agricultural Science, Huazhong Agricultural University.

Professor Fu Tingdong is an academician of the Chinese Academy of Engineering, and a professor of agricultural science at Huazhong Agricultural University, China. He has made outstanding contributions to the

discovery and study of Pol cytoplasmic male sterility and to the development and utilization of hybrid cultivars in rapeseed. He has bred thirteen varieties, with a total accumulative area of over 7.0 million hectares. Recently, he found a new type of CMS. His group has provided the linkage map construction and cloning of genic male sterility genes in this plant. His suggestion of sowing rapeseed as forage during the vacant period after the wheat harvest in northwestern China has provided economic benefits to poor farmers. Professor Fu is the recipient of the Superior Scientist Award of the International Consultative Research Group on Rapeseed (GCIRC), Paris; The Third World Academy of Sciences Prize (agriculture sciences, 2003); Memorial Lifetime Achievement Award, Mustard Research and Promotion Consortium (MRPC), New Delhi; and the National Technology Specialized Talent Prize of China.

of cooperation with University of Manitoba under CIDA sponsorship were highly significant with considerable achieved achievement. In the two-phased project in agricultural education under CCULP and SULCP, which aimed at nurturing an advanced training capability in rapeseed breeding, production and quality control, we welcomed 18 Canadian professors to China for short-term teaching and research exchanges, and we sent dozens of scholars to Canada to conduct joint research. Many of those returned scholars later established themselves as core faculty members and academic leaders and produced high-level research results. Some of them were elected as national academicians, university presidents and outstanding researchers at the provincial level or Yangtze Scholars, who contributed significantly to the fields of agricultural science, soil chemistry, agricultural economics, food science and veterinary & herding sciences. We have actively extended our collaborative exchanges, over the recent decade, with more Canadian academic institutions becoming involved, including the University of Saskatchewan, the University of Guelph, McGill University and the Canadian Research Institute of Agriculture and Food and joint degree programs and research being developed. We have sent over 10 graduate students to conduct research in Canada, and 19 undergraduate students are now pursuing degree programs in the linkage universities.

Presentation: Canada-China collaboration in Engineering Education

Abstract

As a successful case of CCULP in the engineering field, the project on Computer Application in the Northwest Railway System between Lanzhou Railway Institute (LRI) and Ryerson Polytechnic University will be reviewed in a somewhat broader vision. The project benefited LRI in aspects of curriculum development, the upgrading of research ability, the building of closer relationships with enterprises and innovation in school management. This paper will explore the wider impact of these projects on higher engineering education in China where colleges, departments and curricula had been designed according to

triangular relationship among the government, the market and social forces. The success of the project could be attributed to the combination of reform and openness in the surroundings, a sense of the "right time" in the international exchange history of Chinese universities, precise design and preparation, serious execution, and post-project efforts to continue and extend the positive outcomes of the project. The experiences of the CIDA supported Canada-China university linkage programs that were carried out two decades ago need to be studied as a heritage which is valuable to potential further exchanges in higher education and other fields between the two countries.

Abstract

The collaboration between Nanjing University and Canadian universities and research institutes has reached 35 years since 1979. Personnel exchanges for lectures or joint research programs were the first step. For example, Wang Ying was in Dalhousie University and the Bedford Institute of Oceanography, Atlantic Geoscience Centre to do joint research from Feb. 1979 to Feb. 1982 for three years, while Dr. G. Vicks and Dr. D. Buckley from B.I.O visited Nanjing University in 1981 and 1983, and Professor Bruce Mitchell visited NJU for the first time in June of 1989. As the second step of collaboration, gradually, a series of collaborative projects were developed:

- 1. An IDRC project (SECC China 010/IDRC 3P-87-1003-02) was carried out by NJU and BIO from 1988-1992
- 2. A CIDA project (CCHEP282/19736, 1997-2002) was carried out by NJU and University of Waterloo, U. of Guelph, U. of Wilfrid Laurier. This was successfully completed, with the training of more than 50 post graduate students, equal to master degree level, in the remote Hainan Island. Today, most of them are leaders in the different level of local government.



Presentation: The Cross cultural Impact of a Collaborative Linkage on the Academic Leadership of Chinese Universities


The article describes the 20 year collaboration process of the linkage of Xian Jiaotong University and University of Alberta as well as its sister universities supported by Canadian International Development Agency. Then, it demonstrates that the collaboration had an enlightenment effect on the academic leadership of management education of China in 1980s. Afterwards, the dynamic academic leadership development process of scholars involved in the exchanges of the linkage was investigated from across culture perspectives by longitudinal analysis. It summarizes the three steps of enhancing academic leadership of Chinese scholars: Deep understanding of Canadian society through field observation in Canada and personal contact, perceiving the difference between Chinese and Canadian education, culture and learning from the differences and rethinking of them. The development of academic leadership is reflected in terms of four aspects: The approach of Learning & Teaching, just transmitting knowledge versus cultivating critical and creative thinking; the thinking way of research, establishing a theoretical framework vs. solving or explaining focused


